Dear Friends and Supporters,

We are thrilled to share incredible highlights from fiscal 2024^{*}. Remarkable support from our donors is driving exceptional care across our lakeshore hospitals in Muskegon, Shelby, and Grand Haven. While we celebrate every gift, a few stand out:

- The Essex family's generous support enabled the purchase of a **Medistim ultrasound and two cardiac echo machines**, ensuring excellent outcomes for our open-heart surgery patients.
- A generous estate gift allowed us to acquire a **Globus robotic spine navigation system**, enhancing precision for our Neurosurgeons and Orthopedic surgeons in Muskegon.
- With a \$40,000 grant from the Grand Haven Area Community Foundation, Trinity Health Grand Haven secured **a stroke robot**, helping the hospital to achieve Primary Stroke Center certification.
- In December, an unexpected \$100,000 anonymous gift allowed us to refresh the Johnson Family Cancer Center's lobby and fund **equipment that enhances patient comfort during radiation treatments**.

Recently, we connected with Sister Naomi Holysko, who served as the administrator of Mercy Hospital from the late 1960s through the early 1980s. A Donor's Journey Transforming Heart Care at Trinity Health Muskegon Hospital

Local businessman and patient, Bruce Essex, shares his story



Bruce Essex's positive experience with his open-heart surgery led him and his wife, Yvonne, to partner with Dr. Tad Boeve to invest in new technologies that advance the open-heart surgery experience. In October 2022, my life took an unexpected turn when I was admitted to Trinity Health Muskegon Hospital with dangerously high blood pressure. Little did I know, this moment would lead me on a profound journey of discovery and generosity.

Under the care of my cardiologist, I underwent a heart catheterization, which revealed severe coronary artery disease and that stents were not a suitable option for me. My condition required open-heart surgery under the expert care of cardiothoracic surgeon Dr. Tad Boeve and his team.

In the days leading up to the surgery, I delved into researching Dr. Boeve's expertise in openheart procedures. Learning of his esteemed reputation within cardiac surgery, it brought me confidence during a challenging time.

The procedure, which included a triple bypass and an aneurysm repair, was successful. I returned home and remarkably, experienced minimal discomfort.

While expressing my gratitude to Dr. Boeve and reflecting on my journey, I discovered there was an opportunity to enhance cardiac care in Muskegon. A Medistim ultrasound device was identified as a crucial asset, capable of improving surgical outcomes and ensuring vein quality for bypass procedures. To support this, my wife Yvonne, son John, and I proudly contributed to acquiring the first ultrasound, and then a second one, for the Cardiovascular program at Trinity Health Muskegon. The impact was tangible. By November 2023, Dr. Boeve shared this device had already been used for critical surgeries, affirming its value to our community.

With a vision to do more, we met with key stakeholders—Gary Allore, president; Dr. Tad Boeve; Dr. Justin Grill, chief medical officer; and Claudine Weber, chief philanthropy officer. Together, we identified a prioritized list of essential equipment and technologies needed to position Trinity Health Muskegon as a premier destination for heart surgeries, now and well into the future.

Trinity Health Muskegon possesses the infrastructure and expertise to expand its cardiovascular capabilities. Now, we are seeking the support of others to join us as we work to fund the future of cardiac care on the lakeshore.

From the Farm to Philanthropy: **The Inspiring Journey of Sister Naomi Holysko**

Early Life & Religious Calling

Sister Naomi Holysko's story is a testament to resilience and dedication. Born and raised on a farm in Pinconning, Michigan, she was an only child who found companionship in the animals she cared for. Her early years were spent in the countryside, a stark contrast to the bustling cities she would later navigate as a Sister of Mercy. She served as the youngest administrator of Mercy Hospital from 1967 to 1981.

Entry into Religious Life & Education

Sister Naomi entered the convent at the Sisters of Mercy in Detroit at just 17. The training included a year as a postulant, two years as a novice, and four years as a junior sister, during which she pursued higher education in nursing and pharmacy. Sister Naomi completed a pharmacy program at Wayne State University, became a member of Rho Chi Honor Society in 1962, and a master's degree in hospital administration from Saint Louis University in Missouri in 1967, including a residency at Holy Name Hospital in Teaneck, New Jersey.

Professional Achievements & Leadership

Throughout her career, Sister Naomi served in various capacities across multiple hospitals. Her work took her from St. Mary's Hospital in Grand Rapids to Mercy Hospital in Muskegon, where she directed the construction of a new hospital facility in the early 1970s. Despite being in her mid-20s, her leadership ensured a smooth transition from the old hospital to the new state-of-the-art facility with the help of 180

Army Reserve members in April 1973. She also directed the construction of the ambulatory outpatient services building in 1980 (West Shore Professional Building).

Recognition & Tragedy

Sister Naomi was named Muskegon's Woman of the Year in 1976. In the late 1970s, she hired cardiothoracic surgeon, Dr. Steven Demos and other cardiology specialists to begin the hospital's cardiovascular program. She was the administrator during the tragic 1981 plane crash that took the lives of five men traveling for the hospital, board members William White, Jr. and Charles Schuler, Jr., physicians Dr. Davis Amos and Dr. Guido Annessa, and pilot Richard Wilson.

Sabbatical & Further Service

In 1981, Sister Naomi took a year-long sabbatical at Gonzaga University in Spokane, Washington. When she returned, she was elected to the governance of her ministry, serving as Provincial Administrator for the Sisters of Mercy for two four-year terms.

Philanthropic Endeavors

Her parents, who owned a general store and were known for their generosity, greatly influenced her charitable nature. After their passing, she received an inheritance, which she chose to use for the greater good. Living a life of poverty, she channeled her inheritance into supporting the education of young women, health care initiatives, and numerous community projects. At Trinity Health Muskegon, her gifts have supported the Johnson Family Cancer Center, the Breast Center, the Heart Center, the new hospital, the Healing Garden, the Roger W. Spoelman Conference & Learning Center, nursing education, and teddy bears for kids in our care.

Continued Service & Legacy

Sister Naomi's commitment to philanthropy extends beyond financial contributions. She has been an active volunteer, serving on the boards of multiple hospitals and not-for-profit organizations. Her work has provided much needed resources and encourages others to contribute. A poignant example of her philanthropic spirit is her support for teddy bears for kids, inspired by her own cherished childhood teddy bear.

Personal Sacrifices & Community Involvement

Sister Naomi's story is also one of personal sacrifices and unwavering faith. When her father was diagnosed with dementia and Alzheimer's,

she took a sabbatical to care for him until his passing. Today, at the age of 83, Sister Naomi remains actively involved in her community. She chairs the local food pantry, serves as the treasurer of the St. Anne Society at her church, and continues to support those in need, despite health challenges like vertigo.

An Enduring Legacy

Her life motto, "Only Your love and Your will," engraved on her ring when she took her final vows, captures her devotion to God and her community. Additionally, she lives by the principle of taking life one day at a time. Sister Naomi Holysko's journey as a revered Sister of Mercy, a hospital administrator, and a dedicated philanthropist is inspiring. Her legacy is a testament to the lasting power of mercy, compassion, and the importance of giving back to the community.

New Trinity Health Neuroscience Center in Muskegon Offers Advanced Technology and Comprehensive Care

The new Trinity Health Neuroscience Center – Muskegon at 1150 E. Sherman Blvd., is located on the second floor of Trinity Health Medical Center – Sherman Pavilion. The center unites Trinity Health Medical Group neuroscience specialists, offering diagnosis, treatment, and rehabilitation for brain, spine, and nervous system conditions.

"Our specialists can now collaborate in one location, enhancing patient care," said Leanna Krukowski, administrative director of West Michigan Neuroscience Services at Trinity Health Michigan.

As the population ages, the demand for neuroscience care is expected to increase, particularly for conditions like Alzheimer's, stroke, and age-related pain. The center is an \$8.7 million investment, nearly doubling the number of patients the specialists can treat.

Integration, collaboration, and convenience distinguish the Neuroscience Center. The center features advanced technology and specialties including neurosurgery, neurology, spine, rehabilitation, and osteopathic manipulative medicine. It also offers an on-site Patient & Family Resource Center, physical therapy gym, radiology, lab services, and a pharmacy.

This center provides expert, coordinated care close to home," added Leanna.

Satellite Clinic Brings Kidney Transplant Care to the Lakeshore Community

Kidney Transplant Services Expand to Muskegon

The Trinity Health Kidney Transplant Center in Grand Rapids has opened a satellite clinic at Trinity Health Muskegon, enhancing access to kidney transplant services for patients in the Muskegon and Lakeshore areas. This monthly clinic is held at the Trinity Health Neuroscience Center at the Pavilion on Sherman Blvd.

Enhancing Accessibility & Overcoming Barriers

The clinic's establishment is supported by partnerships with local providers. "This enables us to bring essential pre-transplant services closer to Lakeshore patients," said Kelly Summers, Clinical Manager for the Kidney Transplant program.

While surgeries and post-transplant care remain in Grand Rapids, the satellite clinic seeks to improve access to kidney care and addresses transportation challenges some patients face.

For kidney transplant referrals, patients should consult their primary care provider or nephrologist.

A Legacy of Generosity Honoring Joseph T. Riley

Thanks to the late Joseph T. Riley's thoughtful planning and generosity more than 50 years ago, Trinity Health Muskegon received a significant planned gift from his estate. This gift reflects Mr. Riley's deep commitment to our mission and serves as a testament to his enduring legacy in the Muskegon community.

A distinguished graduate of Notre Dame Law School in 1918, Mr. Riley dedicated over five decades to serving as an attorney and counselor in Muskegon. He was known for his integrity, wisdom, and commitment to his clients. For 42 years, he served as counsel to Continental Motors Corporation and held the position of secretary at George Morrell Corporation for 35 years. He was remembered not just as a legal advisor, but also as a compassionate gentleman with a delightful Irish wit.

Mr. Riley was also deeply engaged in community affairs, serving as Chairman of the Civil Service Commission and contributing to the Advisory Board of Mercy Hospital. He was a member of the Century Club, Knights of Columbus, and the Notre Dame Club of Muskegon, and a communicant of St. Mary's Church.

Mr. Riley was married to Lucille Garrett, with whom he raised a son, James J. Riley. Joseph T. Riley's remarkable journey began in 1895 and continued until his passing in 1975.

We extend our deepest gratitude to Mr. Riley. With this gift, his legacy will continue to transform lives for generations to come.

Sam Pringle, critical care paramedic, added, "Having Power-LOADS increases our ability to hire and retain EMTs and paramedics and expands our possible recruitment base because it levels the playing field on some of the physical requirements."
