



Questionnaire Instructions:  (1) Only one 'yes' answer should be recorded on the questionnaire.  (2) The questionnaire should not be completed more than once during the vaccination reporting period which ends on 11/30/24. If you need to update your vaccination record after November 30, 2024, please reach out to your ministry's Employee Health Office or contact the HR Shared Services Center through the HR4U portal.  (3) If you received your flu vaccines elsewhere, you are required to upload a copy of your vaccination record. Failure to provide sufficient proof of your 2024-2025 flu vaccine may require you to locate and submit proof later for audit and regulatory compliance.  Thank you for your commitment to preventing the spread of the flu.
