Saint Mary's Foundation established two funds to provide relief to Mercy Health Saint Mary's and our colleagues.

The COVID-19 Response Fund was created to impact the most immediate needs and benefit the care of our patients and community. To date, because of your generosity we have raised over \$475,369 to help meet ongoing needs as many resources are being directed to fight this virus.

Healthcare Heroes

Mercy Health Saint Mary's and Cherry Health, in coordination with Kent County Health Department, tested all guests who were staying at the Mel Trotter Ministries in downtown Grand Rapids.

On Monday, April 20, 2020 Mercy Health Saint Mary's and Cherry Health began by testing the men and women who are at highest risk for COVID-19, with the goal of having results by Tuesday, April 21. In addition to the 110+ guests who came to the testing centers, the Saint Mary's staff visited Mel Trotter the next day to continue testing those who were not able to travel.

By getting all (Mel Trotter) guests tested for COVID-19, we can support safe housing and public health at Mel Trotter Ministries, which serves more than 400 guests per night at its facility in the Heartside neighborhood.

Mercy Health provided testing to guests at its Wege Parking Garage Test Center, and Cherry Health at its walk-up tent, each providing appropriate personal protective equipment (PPE) to Mel Trotter onsite staff, along with healthy snacks and a safe waiting area for those being tested.

"This is a proactive strategy to reduce transmission in this at-risk community," said Liberty Jacques, DNP, RN, ACNS-BC, CIC, Director of Infection Prevention & Control and Professional Practice & Development, at Mercy Health Saint Mary's. "Offering this testing to one of our most vulnerable populations embodies Mercy Health's commitment to be a compassionate and transforming healing presence within our community."

"Partnering with Mercy Health and other community agencies to address the health needs of our most at-risk community members reduces disparities in healthcare access. We are pleased to partner and look forward to further narrowing the

gap through these relationships," said Kerrie Barney, Director of Nursing at Cherry Health.

Mel Trotter Ministries provided a list of guests needing testing, and then transported guests four at a time by van to the testing sites. The process was smooth, allowing a few people at a time to be tested and transported to and from the testing site.

As incentive to participate, Kent County Health Department supplied individuals who were tested with bus vouchers. McDonald's also donated gift cards which Mercy Health Saint Mary's staff distributed to all who were tested.

Guests waited at Mel Trotter until they received their results. "Between Monday and Tuesday we were able to test 251 individuals and 69 of those tested positive." said Andrew Jameson, MD, Division Chief of Infectious Diseases at Mercy Health Physician Partners. Once results were back, housing was organized to separate those who have tested positive from those who tested negative.


"Individuals experiencing homelessness are some of the most vulnerable yet underserved people in our community," said Dennis Van Kampen, President/CEO of Mel Trotter Ministries. "There is no way we could continue to provide all of the support that is required during this crisis on our own. The testing that Mercy Health Saint Mary's and other local healthcare organizations is providing will help flatten the curve both within our mission and within the West Michigan community at large. We could not be more grateful for their generous assistance during this time."

Tell us a little about yourself:

I was born in Ghana, West Africa and migrated to the United States to join my husband in 1999. At the time, my husband was on an H1B visa so I couldn't work. As a stay-at-home mom, I spent my time preparing for the LSAT because I wanted to be a lawyer. Eventually, my husband and I got our green card qualifying me to look for employment. After several interviews, I landed a job at Bank One as a teller. Although I had an undergraduate degree in English from Ghana, I was teased by my colleagues and sometimes humiliated by customers because of my accent. That didn't deter me; I persevered. After my first child was born, I gave up my dream of becoming a lawyer and enrolled in Nursing school. As an immigrant, those were the hardest three years of my life. I took care of the baby during the day and attended school in the evening. Looking back, we had no family, no help but just made it work. During my second year in Nursing school, I got a job at Mercy Health Saint Mary's as a Patient Care Assistant (PCA). That's the beginning of whom I am today.

Why did you choose to go into health care?

Although law was my dream profession, I had to rethink that soon after my first child was born. After analyzing my options carefully, an accelerated nursing school program became my best option. I chose nursing because of the job prospect but I fell in love once I started working as a PCA at Mercy Health Saint Mary's. The adrenalin of trying to save a life was outweighed by the gratification of team work and "Thank You" from patients and their family.

Why do you choose to stay at Mercy Health Saint Mary's?

I'm a staunch Catholic. Mercy Health Saint Mary's humanizes that Catholic teaching. In the ER, we care for everyone who walks in regardless of race, ethnicity or wealth. We don't turn

anyone away. It's that care for humanity that sets Mercy Health apart and that's one of the main reasons I love this organization.

What is your proudest moment in your health care career?

Over the past fourteen years, I have worked in the emergency department as a nurse caring for countless patients who are in their most weak and vulnerable states. My dear mother suddenly became ill in early 2019 and what made the situation even more difficult is that I live in Michigan while my mother lives in my homeland of Ghana. Throughout her illness, I was thankful for technology as I was able to easily communicate with my brothers through the phone calls and video calls to help care for my mother.

Unfortunately, my mother's health was not improving, and it became clear to me that all of my years as a nurse caring for others was preparing me for my most challenging assignment yet. In March of this past year, I was able to spend a couple weeks caring for her and making memories which have proven to be invaluable. Unfortunately, my mother passed away two months after I returned to Michigan. Out of all the patients I have ever had the privilege to care for, caring for my mother during her most vulnerable state was by far the most challenging and rewarding I have ever experienced. I feel truly blessed to be able to provide comfort and peace to my mother who has always loved me so much.

What do you enjoy doing outside of work for fun?

Outside of work, it is all about my family; that includes my immediate family, my extended family in other parts of the world and close friends that I consider part of my family. I'm blessed with a husband of 19 years, an 18-year-old daughter and 13-year-old son; they're my pride and my joy. I love cooking traditional Ghanaian foods and sharing with my American friends. I also love to travel and see new places.

What motivates you during these challenging times in health care?

Nursing is a challenging job and it's during challenging times that our patients need us most. This is very evident during COVID-19. The desire to do my very small part in taking care of patients, the gratification from their families but more so, seeing the joy that people feel is very humbling. There's no better motivation.

HOPE RUNS DEEP. Nana's Run, a special 5k race, went virtual this year. The virtual run allowed individuals to log their 5k in honor of a specific patient or the entire Amyotrophic Lateral Sclerosis (ALS) population. Raising more than \$220,000 this year, Nana's Run has raised over \$2 million over the last seven years to support the efforts of ALS.

The ALS Association Michigan Chapter and Mercy Health Hauenstein Neurosciences, in partnership with the Daniel and Pamella DeVos Foundation, presented the seventh year of Nana's Run, which is the creation of the event chairpersons, Cassandra DeVos and Sydney DeVos Reames. The race is a tribute to their beloved maternal grandmother Char VanderLaan, affectionately called Nana, who passed away on March 7, 2014 after battling ALS. Since Nana VanderLaan was diagnosed with ALS in October 2013, the DeVos granddaughters have made a commitment to raise awareness about the disease and to raise funds that will support patient and physician education, ALS patients and their families, and ongoing research within Michigan.
