# Saying Farewell to BELOVED FRIEND MAVIS THILL

The Mercy Health Muskegon Heart & Vascular Center and the Critical Care Unit bear the name of Dan and Mavis Thill in honor of their contributions to cardiovascular health. The Thills' history with Mercy Health began nearly 30 years ago when Dan served on our hospital board. Together, Dan and Mavis created a legacy through our Heart & Vascular Center and Critical Care Unit. With Mavis' passing in November 2017, we said farewell to our extraordinary friend and supporter. The Heart & Vascular Center and one of the Intermediate and Intensive Care Units in our new medical center will be named for the Thill family.

## Lessons learned in youth inspire lifelong service

Such is the case with Mercy Health Muskegon President Gary Allore and his wife, Sue.

The Allores, who are supporters of the new medical center campaign, have always lived in Muskegon. After a nationwide search, Gary was named president of Mercy Health Muskegon in September 2017. Gary's father built a successful plumbing business, while his mother was involved with and supported every aspect of the company.

"My parents worked hard, and their largest desire was to help," said Gary. "My father always loved to do service calls because he felt those calls — going out to help people in immediate need — were the absolute heart and soul of his business."

Sue recalled her first job at the restaurant founded by her grandfather — Muskegon's Doo Drop Inn. Eventually, she held every job — waitress, hostess and cook — in the legendary eatery.

"Everyone in our family grew up in the restaurant," she reminisced. "And, we were never allowed to say: "That's not my job.""

Today, Sue is a leader when it comes to community service and volunteering, with no project too small for her to undertake. She serves on local boards, is a member

of Women for Health, and finds herself helping numerous causes several times a week. Her life is indeed one of service.

Gary is equally dedicated to helping meet needs through service to Mercy Health Muskegon and several area not-for-profit organizations.

Their parents instilled a sense of dedication to the place they call home. This legacy of caring continues through Gary and Sue today. West Michigan, they say, holds absolutely everything for a good life: rewarding work, volunteer opportunities, beauty and, most important, loved ones.

#### Philanthropy Impact

The Office of Philanthropy was able to award more than \$3 million to our ministry due to the many generous gifts and contributions from individuals, businesses and foundations. Highpoints of the year included the purchase of a computerized tomography (CT) scanner for the Johnson Family Cancer Center (funded solely from philanthropy giving), the completion of the Reflection Room at the Lakeshore Campus and significant patient financial assistance.

#### Hackley Free Bed Guild

#### Mercy Health Volunteer Board

## TRANSFORMATIONAL Health Care

#### The new Mercy Health Muskegon medical center construction is nearly halfway complete.

In just a few months from now, the first phase of our Emergency Center and our surgical and interventional rooms will open.

The installation of the building's final exterior panels will take place this summer, turning the building from green to shades of white.

Inside the building, the core electrical and plumbing components have been installed. Hallways and rooms are beginning to take shape. This summer, the pace picks up as the focus moves to finishing the first phase.

"When our staff visit the construction site they are inspired.

They see that everything is designed for our patients. When our new medical center opens in 2019, how we work will be much more efficient. This will allow us to spend more time with our patients," said Nick Strait, director of clinical consolidation, MSN, MBA, RN, NEA-BC.

Mercy Health recently received approval to invest an additional \$19.6 million in the new medical center for the outfitting of the 10<sup>th</sup> floor and the renovation and expansion of the kitchen and dining area. This increases the total investment of the Mercy Health Muskegon medical center project from \$271.4 million to \$291 million.

The medical center will open in three phases. In November 2018, the Emergency Center and the surgical and interventional procedure rooms will open. In Spring 2019, several inpatient floors will open. The final phase will open in fall 2019 with the completion of all remaining floors.



Nick Strait, director of clinical operations, MSN, MBA, RN, NEA-BC, is leading the coordination of the clinical operations for the new medical center. This includes inpatient floors, the Emergency Center and the new Universal Care Unit.

This campaign is a chance to share in a very special legacy that will extend to our loved ones and future generations. As of March 2018, we achieved


\$10.1 million of our \$12.5 million campaign goal. We are overwhelmed and grateful for the exceptional support we have received thus far.
